The trustees may determine the tikanga of Raukawa Settlement Trust by which whāngai (persons who may not affiliate to Raukawa Settlement Trust by descent from Raukawa Settlement Trust but who are adopted by a member of the Raukawa Settlement Trust in accordance with tikanga or with the Adoption Act 1955) or other persons who do not descend from the primary ancestor of Raukawa Settlement Trust are able to affiliate to Raukawa Settlement Trust.

The board reserves the right to disallow any application because of insufficient or incorrect information. The onus for inclusion onto the Raukawa Settlement Trust register of beneficiaries is on the applicant and not on the board.
